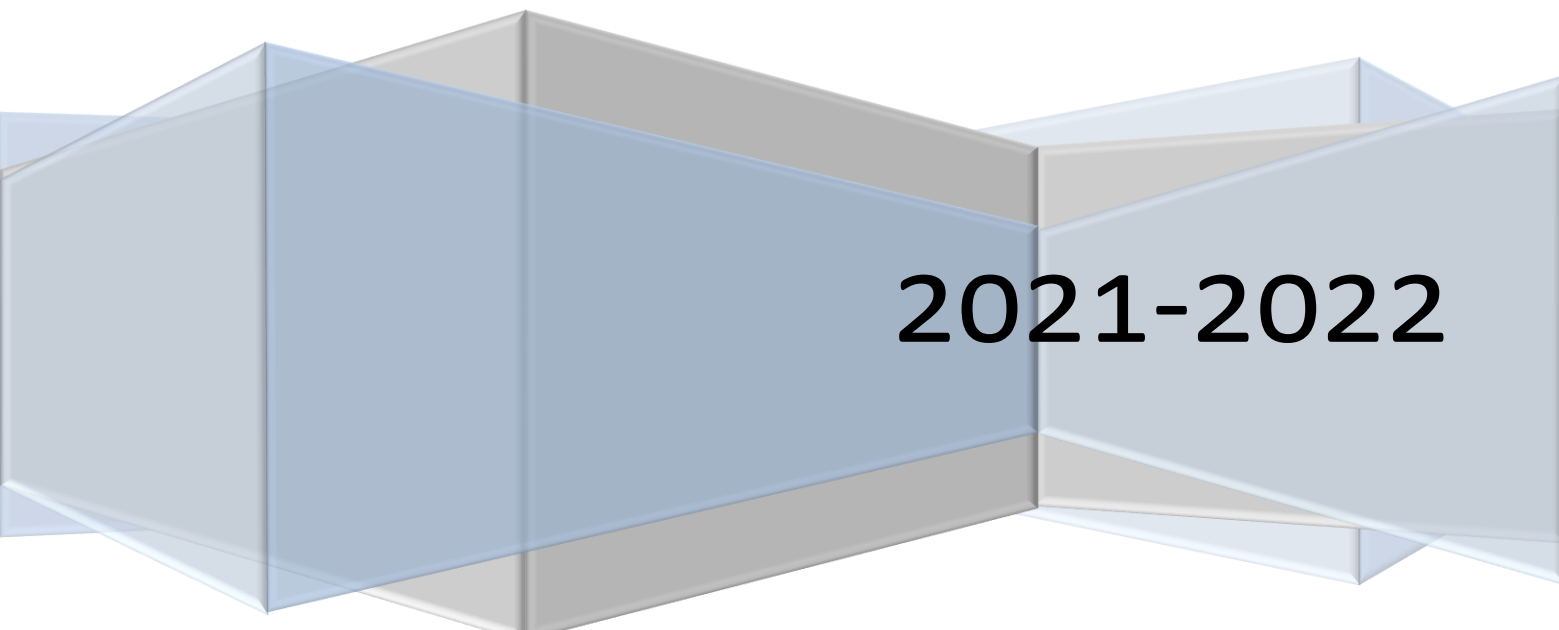

## *Premessa*

Il Gruppo di Lavoro ha preso in esame alcune tra le principali categorie di finanziamenti UE 2021-27 con l'obiettivo di produrre delle schede informative finalizzate alla promozione di opportunità di finanziamento alla ricerca internazionali meno note, ma altrettanto interessanti, rispetto a *Horizon Europe*. Nello specifico, ci si è focalizzati su alcuni *Programmi, Fondi, Strumenti di finanziamento* e su *Altre opportunità di finanziamento* UE quali le *COST Actions*, i finanziamenti della *European Space Agency* e le *Calls for Tender*.

Il lavoro, che si è svolto tra metà maggio e metà ottobre 2021, ha prodotto quattordici schede informative sulle singole opportunità di finanziamento. Si tratta di schede sintetiche ma complete delle informazioni utili, redatte in lingua inglese e pensate per un utilizzo da parte degli Uffici competenti, così come dei ricercatori e docenti in autonomia.

Ciascuna scheda include quattro sezioni: una dedicata alla generale descrizione dell'opportunità di finanziamento, una seconda con i contatti utili, una terza dedicata ai dettagli (opzionale) e una quarta che illustra ampiamente le tipologie di azione associate. In calce a ogni scheda è altresì riportata la data del relativo aggiornamento. Al fine di facilitare eventuali operazioni di aggiornamento da parte dei fruitori, sono stati inoltre indicati i link ai siti istituzionali che presentano le call.

È appena il caso di sottolineare che le schede non sono esaustive dell'intero panorama delle opportunità di finanziamento esistenti, ma intendono approfondirne alcune tra quelle ritenute di maggiore interesse, al fine di ampliare il quadro delle opportunità normalmente diffuse e gestite dagli Uffici ricerca. Le schede sono state inoltre copilate solo con riguardo alle tipologie di azione per le quali le Università risultano eleggibili e alle informazioni ufficiali disponibili al momento della compilazione.

Tali schede possono essere fruite anche tramite la ricerca di parole chiave.

I lavori sono stati svolti tramite incontri da remoto, con il supporto di una piattaforma online per la condivisione della documentazione.

I lavori hanno permesso ai partecipanti di confrontarsi anche su ulteriori temi, quali le modalità di scouting e diffusione delle opportunità di finanziamento, nonché di monitoraggio delle proposte presentate.

## CERV - Citizens, Equality, Rights and Values

### Section I - Programme/Fund/Instrument

**Name Programme/Fund/Instrument:** Citizens, Equality, Rights and Values Programme (CERV)

**Short description of the programme:** The Citizens, Equality, Rights and Values programme (CERV) brings together the former Rights, Equality and Citizenship (REC) and Europe for Citizens programmes.

This programme aims to protect and promote Union rights and values as enshrined in the EU Treaties and the Charter of Fundamental Rights. It will contribute to sustain and further develop open, rights-based, democratic, equal and inclusive societies based on the rule of law.

**Duration:** 2021 - 2027

**Sub programmes/programme structure:**

CERV work programme 2021-2022 supports the accomplishment of **four main objectives** which correspond to four strands of activities:

1. To protect and promote Union values (Union values strand);
2. To promote rights, non-discrimination and equality, including gender equality, and to advance gender mainstreaming and the mainstreaming of non-discrimination (equality, rights and gender equality strand);
3. To promote citizens' engagement and participation in the democratic life of the Union and exchanges between citizens of different Member States, and to raise awareness of their common European history (citizens' engagement and participation strand);
4. To prevent and combat gender-based violence and violence against children (Daphne strand).

# CREATIVE EUROPE

## Section I - Programme/Fund/Instrument

### **Name Programme/Fund/Instrument:**

Creative Europe

### **Short description of the programme:**

Creative Europe brings together actions supporting the European cultural and creative sectors.

The term '**Cultural and creative sectors**' means all sectors whose activities are based on cultural values or artistic and other individual or collective creative expressions. The activities may include the development, the creation, the production, the dissemination and the preservation of goods and services, which embody cultural, artistic or other creative expressions, as well as education or management, related to these activities. The sectors include, inter alia, architecture, archives, libraries and museums, artistic crafts, audiovisual (including film, television, video games and multimedia), tangible and intangible cultural heritage, design (including fashion design), festivals, music, literature, performing art (including theatre and dance), books and publishing, radio, and visual arts.

The general objectives of the Programme are:

- to safeguard, develop and promote European cultural and linguistic diversity and heritage;
- to increase the competitiveness and the economic potential of the cultural and creative sectors, in particular the audiovisual sector.

### **Duration:**

2021-2027

### **Sub programmes/programme structure:**

Three strands:

- enhancing artistic and cultural cooperation at the European level, in order to support the creation of European works and strengthen the economic, social and external dimension of and innovation and mobility in Europe's cultural and creative sectors (**CULTURE strand**);
- promoting the competitiveness, scalability, cooperation, innovation, and sustainability, including through mobility in the European audiovisual sector (**MEDIA strand**); and
- promoting policy cooperation and innovative actions supporting all strands of the programme, promoting a diverse, independent and pluralistic media environment, and media literacy, thereby fostering freedom of artistic expression, intercultural dialogue and social inclusion (**CROSS SECTORAL strand**).

Capacity building activities, preparation of artistic works, circulation of artists, digitization, training, networking, conferences, workshops, symposia, seminars, research, studies, policy analysis, surveys, laboratories, studies, etc. are funded.

## DIGITAL EUROPE

#### **Name Programme/Fund/Instrument:**

Digital Europe Programme (DEP)

#### **Short description of the programme:**

The Digital Europe Programme (DIGITAL) is a new EU funding programme focused on **bringing digital technology to businesses, citizens and public administrations**.

The Digital Europe Programme will provide strategic funding to make Europe greener and more digital, supporting projects in **five key capacity areas**: in supercomputing, artificial intelligence, cybersecurity, advanced digital skills, and ensuring a wide use of digital technologies across the economy and society, including through Digital Innovation Hubs. With a planned overall budget of €7.5 billion (in current prices), it aims to accelerate the economic recovery and shape the digital transformation of Europe's society and economy, bringing benefits to everyone, but in particular to **small and medium-sized enterprises**.

The Digital Europe Programme will not address these challenges in isolation, but rather **complement** the funding available through other EU programmes, such as the **Horizon Europe** programme for research and innovation and the **Connecting Europe Facility** for digital infrastructure, the **Recovery and Resilience Facility** and the **Structural funds**, to name a few. It is a part of the next long-term EU budget, the Multiannual Financial Framework 2021-2027.

#### **Name Programme/Fund/Instrument**

Erasmus+ 2021-2027

#### **Short description of the programme:**

Erasmus+ is the EU's programme to support education, training, youth and sport in Europe.

The 2021-2027 programme places a strong focus on social inclusion, the green and digital transitions, and promoting young people's participation in democratic life.

It supports priorities and activities set out in the European Education Area, Digital Education Action Plan and the European Skills Agenda. The programme also:

- supports the European Pillar of Social Rights
- implements the EU Youth Strategy 2019-2027
- develops the European dimension in sport

Erasmus+ offers mobility and cooperation opportunities in higher education, vocational education and training, school education (including early childhood education and care), adult education, youth, and sport.

#### **Duration:**

2021-2027

#### **Sub programmes/programme structure:**

The Programme covers three sectors:

- **Education:** higher education, vocational education and training, school education (including early childhood education and care), adult education
- **Youth**
- and **Sport**

For each sector, three Key Actions are planned:

- **Key Action 1 - Mobility of Individuals.** It deals with the mobility of learners and teachers, young people, operators of youth organisations as well as operators in sport organisations;
- **Key Action 2 – Cooperation among organisations and institutions:** it supports collaborative projects involving organisations from the interested sectors to share best practices, improve the educational offer, to foster the sectoral excellence at European level
- **Key action 3 – Support to policy development and cooperation:** it supports initiatives aimed at preparing and supporting the implementation of the EU policy agenda in the three sectors.

In addition to these three Key Actions, the **Jean Monnet Actions** will support teaching and research on European integration and promote policy debate and exchanges involving the academic world and policymakers on Union policy priorities in higher education and (since 2021) in other in schools and vocational education and training (VET) institutes.

Under each Key Action, different types of actions are supported. Some of them are managed centrally by the European Commission through the EACEA (European Education and Culture Executive Agency), some others are managed at national level by National agencies (one or more per each Programme country).

The detailed sheets under Section IV “Type of Action” cover only the actions of interests to Universities.

#### **Thematic areas:**

The Erasmus+ has a bottom-up approach. Therefore, **all ERC thematic areas are relevant**, according to the specific discipline or business sector considered by the individual project proposed. As far the focus is on methodology, social sciences like education, psychology and other social sciences might play a pivotal role in many applications.

#### **Purpose of funding:**

Erasmus+ Programme is not a research funding programme. Nonetheless, it supports studies, analyses and other type of “applied” research activities to improve the policies and the actions in the three sectors.

#### **Eligible countries**

Eligible countries are divided into two groups, Programme countries and Partners countries. Although Programme countries are eligible for all actions of Erasmus+, Partner countries can only take part in some, and are subject to specific conditions.

#### **Programme countries are:**

- EU Member States
- Non-EU Programme Countries (currently Republic of North Macedonia, Serbia, Iceland, Liechtenstein, Norway, Turkey).

In addition, other countries not associated to the Programme (called **Partner countries**) can only take part in some and are subject to specific conditions.

### **Erasmus Mundus Joint Masters (EMJM)**

The EMJM includes compulsory physical mobility for all enrolled students (holders or not of an EMJM scholarship), which consists of at least two periods of study in two countries, of which at least one must be a Programme country.

### **Erasmus Mundus Design Measures (EMDM)**

#### ***Jean Monnet Actions in the Field of Higher Education***

EU studies should promote active European citizenship and values and deal with the role of the EU in a globalised world, enhancing awareness of the Union and facilitating future engagement as well as people-to-people dialogue.

The Jean Monnet in the Field of Higher Education must take one of the following forms:

**Jean Monnet Modules**: Modules are **short teaching programmes or courses** in the field of European Union studies at offered at a higher education institution. Each Module has a **minimum duration of 40 teaching hours per academic year** for a duration of **three years**. Modules may concentrate on one particular discipline in European studies or be multidisciplinary in approach and therefore call upon the academic input of several professors and experts. They can also take the form of short specialised or summer programmes.

#### **Strategic Nature Projects (SNAP)**

**Type of action:** call for proposals.

SNAPs support the full implementation of the following plans and strategies:

- **Prioritised Action Frameworks (PAF)** pursuant to **Article 8 of Council Directive 92/43/EEC** on the conservation of natural habitats and of wild fauna and flora (the **Habitats Directive**); and
- Other plans or strategies adopted at international, national, regional or multiregional level by nature and biodiversity authorities, that implement EU nature and/or biodiversity policy or legislation and include specific and measurable actions, or targets, with a clear timeline and budget.

The SNAP shall:

- include strategic actions to **catalyse a process** and **mobilise supplementary commitments and funding** that will lead, in due time, to the full implementation of the plan or strategy;
- promote the **coordination** with and **mobilisation of other relevant Union, national or private funding sources** for the implementation of the **complementary measures** or actions outside of the SNAP;
- **actively involve** the main **stakeholders** - in both the design and implementation of the given project- necessary for the implementation of the targeted plan or strategy. This involvement is expected to be achieved by including them - where possible and reasonable - as associated beneficiaries of the SNAP, or through their active participation in the implementation of the SNAP itself and/or of the complementary actions.

The set of measures to be included in a SNAP programme of **actions** shall include the following:

- institutional support and capacity building actions;
- mobilisation and coordination of additional finance for complementary actions, in particular from other EU funding instruments and programmes;
- concrete conservation and restoration measures, in particular where these cannot be supported through other EU funding programmes.

→ A SNAP full proposal cannot be submitted in the absence of a PAF approved/adopted at the appropriate level and submitted to the European Commission which considered it of acceptable quality.

The SNAP complexity requires an adaptive approach in the design of the implementing mechanism. For this reason, SNAPs will be implemented based on a revolving programming mechanism structured in phases (i.e. Phase 1, Phase 2, etc.). Each phase should normally last at least 3 years, to reduce administrative burden, although duration might be shorter if properly justified.

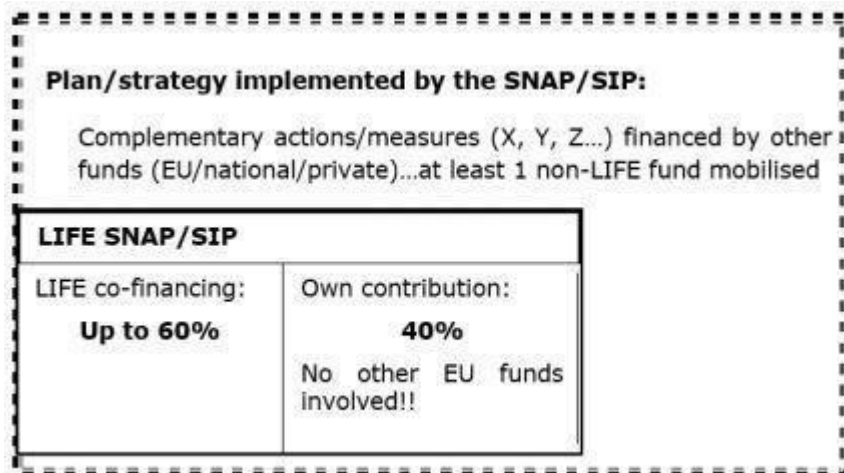

In particular, the LIFE Programme should be **complementary to other major Union funding programmes**. In addition, international (e.g. EFTA, UNESCO funds, etc.), national or private donors will be equally considered.

*Please note that international, national, and private funds (excluding EU funds) can also contribute **cofinancing to the 40%** of the eligible costs of the SNAP itself, which have to be provided by its beneficiaries.*

- Maximum funding:60%
- actual costs, with unit cost and flat-rate elements;
- indirect cost flat-rate: 7% of the eligible direct costs

**Duration of projects:** (Min/max): 60 - 120 months

**Deadline:** yearly.

The proposals will have to follow a **two-stage submission procedure**.

In the first stage, applicants will be requested to submit only an outline application, which will be evaluated against a first set of award criteria. Successful applicants will be invited to submit a full application for the second stage which will then be evaluated against the full set of award criteria. Between stage 1 and 2, there will be a written question and answer phase, during which successful applicants can submit questions on the preparation of full proposals.

It is implemented by using "programme co-fund actions". It allows for programme collaboration in any part of the entire research-innovation cycle.

The main and compulsory activity of the ERA-NET programme is the implementation of the co-funded joint call for proposals that leads to the funding of trans-national research and/or innovation projects.

2) *Travel expenses* – for permanent and non permanent staff declared in the project

B) Consumables

C) External activity costs – advisory/consultant services, services supply (scientific, logistics for meetings, devices and machine rent and/or , etc.)

The costs at point C) need to be indicated and detailed as “Other costs” in the financial plan of the joint call application form (online submission)

D) Equipments – Only use cost (related to the project duration) for scientific equipment will be reimbursed.

E) Overheads – no more than 12% of the total amount of the above mentioned costs (A+B+C+D)

F) Coordination - if the Italian institution is also playing the role of coordinator the eligible costs are those indicated in the User’s manual. In the joint call Mipaaf will pay the coordination cost calculated on the total request of the project, including the amount not paid with national resources.

### **Duration of projects: (Min/max)**

The duration of the projects can vary from 2 to 5 years. Usually, the projects have a duration of 3 years (36 months)

## Calls for Tender

### Tender Instrument

A call for tenders is a procedure that the European Institutions use to procure a wide variety of goods, services or works in support of its EU objectives. Every year numerous contracts are awarded through calls for tenders (public procurement procedures), ranging from supply of office furniture, provision of translation services to maintenance of buildings. These call for tenders result in the conclusion of a public contract. The rules that apply to call for tenders have been specifically designed to ensure that all economic operators operate on a level playing field and that the winning tender ensures the best value for money for the EU taxpayer.

### Framework contract

A Framework Contract (FWC) is an agreement between one or more *Contracting Authorities*, and one or more *Economic Operators*. The *contracting and awarding procedures* followed by the Contracting Authorities are used to identify a consultant, supplier, contractor or beneficiary, to request them to provide defined services, supplies, works with the objective of concluding contracts with them.

For Framework Contracts, the *request for tender submission* is the Request for Service; the *providers of the service* are the Framework Contractors (sole or part of a consortium); and the *procedure and award type* is a Specific Contract under a Framework Contract. Specific Contracts can have a Fee-based or Global Price *payment modality*.

Once a Request for Service has been *authorised for publication*, the OPSYS system automatically sends the *Request for Service* to the selected Framework Contractors that receives an invitation to submit a tender submission – via the Funding and Tender Opportunities Portal (Funding & Tenders Portal). After *acknowledging the invitation, expressing willingness* to participate in the tender, *creating and submitting* an offer via eSubmission, the Contractors are automatically notified by OPSYS if the proposal submitted has been *awarded, reserved* or *rejected* by the Evaluation Committee.

When *awarded* and *notified*, the best tenderer *signs* the Contract via the Funding & Tenders Portal, where they will also *manage* the full life-cycle of the Contract (deliverables, invoices and payments, amendments, closure, etc.).

A first aspect is related to the formal fulfillments related to unusual situations such as, for example, the organization/management by an institution based in country C1 of the travel arrangements for a scientist based in country C2 and going to country C3.

A second aspect concerns the reimbursement of subsistence and lodging costs. For this cost category, COST rules foresee a lump sum reimbursement. The Italian legislation favors instead the reimbursement of actual costs; it allows indeed also the reimbursement of lump sums but enforces in this case the application of taxes. The resulting fiscal complication is a source of problems which creates, among others, an additional burden in the project management efforts. For the reasons mentioned above, Italian institutions tend not to take the coordinator role, with project management responsibilities, but rather to engage in scientific coordination tasks.

**Open Discovery Ideas:** This call for new ideas is part of ESA's strategy for the future of European space activities.

ESA is looking for new ideas related to space activities and novelty is the differentiating factor for this research tool. It is therefore very important to describe the idea in a short, direct and clear way, and to specifically emphasize why the idea is new compared to the state of the art and published approaches and how it relates to the space.

**ESA Discovery implementation schemes:** they provide for three main implementation paths:

**1. co-financed research:** at doctoral or post-doctoral level, max. 50% and up to 90.000 € from ESA. The researcher should highlight the novelty of his idea and the latest published research in this field. The researcher should refer to Google Scholar or ESA's publication repositories.

**2. pre-competitive technological development activities:** (max 175.000 € of ESA funding), the researcher should already specify the difference that he would provide with respect to the state of the art in the specific technical domain. Early technology development activities are typically implemented in two phases (proof of concept, demonstration) with an intermediate assessment point where ESA will decide whether the activity should continue or not. A written declaration of industrial interest from the client interested in using the technology should be provided for this funding instrument. More than one industrial letter of interest is allowed and encouraged.

**3. system studies:** (max 100.000 € of funding), the researcher should already describe the novelty at the system level compared to previous system studies and the specific focus it suggests.

For all implementation paths, selection will be a two-stage process: an idea stage and a proposal stage.

The first step is to propose an idea through the dedicated ESA website. Ideas that are deemed suitable for implementation within ESA and are positively evaluated by the evaluation committee will be invited to the second phase, the proposal phase, which:

- **for pre-competitive study and technological development activities** they will be implemented under ESA's standard procurement approach; the activities will follow the Agency's procurement rules and ultimately lead to the signing of a contract with ESA.
- **for the co-financed research activities** an accelerated implementation mechanism will be followed with the disbursement of a grant to the researcher directly by ESA.

Ideas will be evaluated monthly, typically during the third week of each month.

The first phase (idea phase) ends with the evaluation of the idea which is based on the novelty and information provided in the description of the idea itself.

Depending on the implementation path, during the second phase (proposal drafting phase) the researcher will be invited to describe his idea in a project proposal.

The ideas that will be successfully implemented will be made public on the ESA website with the title and abstract provided in the proposal (second phase).

If the idea is selected, the researcher will be invited to formulate his project proposal on a special online form.

- **for co-funded research activities:** the researcher should complete the research proposal on OSIP as quickly as possible, but no more than 4 months after the selection of the idea. The research proposals are then also evaluated monthly and the best five per month will be directly funded without further technical iterations necessary.
- **for pre-competitive study and technological development activities:** they will be selected for implementation through ESA's standard procurement scheme. Shortly after the selection of the idea, the researcher will receive a formal invitation to submit a proposal to the Agency, with further detailed information on the process. The sending will be made with the ESASTAR tool.

Some selected businesses will not need a contractual implementation. For those who have a contractual implementation, ESA will choose the most suitable option. The two standard options are ESA's standard procurement approach or ESA's grant such as the EISI scheme. ESA will make this decision on the basis of its assessment of the direct application of the results of the activities to ESA projects.

- The grant approach involves the signing of an EISI Agreement (EISI Discovery Agreement).
